Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) seeks applications for funding programs that support cross-system collaboration to improve public safety responses and outcomes for individuals with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs). This program furthers the DOJ's mission by strengthening public safety and increasing community trust.

This solicitation is one of two solicitations available as part of the Justice and Mental Health Collaboration Program funding in FY 2023. For law enforcement-focused projects, see the separate law enforcement-focused solicitation entitled "Connect and Protect: Law Enforcement Behavioral Health Response Program."

Additionally, to further assist people with co-occurring MHSUDs, the Comprehensive Opioid, Stimulant, and Substance Abuse Program, the Residential Substance Abuse Treatment for State Prisoners Program, and the Improving Substance Use Disorder Treatment and Recovery Outcomes for Adults in Reentry are three other BJA programs that support the provision of behavioral health treatment and services. Not all entities are eligible for all programs. Applicants are encouraged to review each solicitation in its entirety to determine their eligibility, if it fits their proposals, and if taking advantage of another funding opportunity could further enhance a comprehensive approach to supporting individuals with mental health and/or substance use treatment and recovery support needs that have come in contact with the justice system. Additional details on the three programs can be found on the BJA List of Programs page.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP

for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Other

Agencies with a different legal status (e.g., nonprofit or for-profit mental health agencies) are eligible to apply **only if they meet the following two requirements:**

- 1. The applicant is designated by the state mental health authority to provide services as a unit of the state or local government.
- 2. The applicant must attach documentation to support this designation.

BJA will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the OJP Grant Application Resource Guide.

BJA may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Submission Information

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to fund cross-system collaboration programs to reduce criminal justice (CJ) system involvement and improve outcomes for individuals with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs) who have come into contact with the CJ system or are leaving a custodial setting.

BJA will only accept applications that demonstrate the proposed program will be administered jointly by an agency with responsibility for criminal or juvenile justice activities and a mental health agency.

Statutory Authority

Public Law No. 90-351, Title I, Sec. 2991 (codified at 34 U.S.C. 10651); (Public Law No. 117-103, 136 Stat. 49, 127). Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328; 136 Stat. 4459, 4537).

Specific Information

JMHCP specifically funds collaborative programs to reduce criminal justice involvement by and improve outcomes for individuals with MHDs or MHSUDs who have come into contact with the CJ system or are leaving a custodial setting. Program activities include connecting individuals who have MHDs or MHSUDs with treatment and social services through support for the 988 national suicide and mental health crisis lifeline with programs and services including case management, crisis stabilization units and pre-arrest diversion, creating or expanding mental health courts or other court-based approaches to preliminarily qualified individuals, increasing prosecutor- or defense-led diversion strategies, creating connections with entities and/or providing supported employment services for people with behavioral health needs, utilizing specialized caseloads for probation, cross-system training of public safety officials and mental health providers, and increasing intergovernmental cooperation between state and local governments to support individuals with MHDs or MHSUDs.

For the purposes of this FY23 JMHCP solicitation, the definition of someone with MHD and the services that could be provided to individuals through this program includes individuals with traumatic brain injury (TBI) and post traumatic stress disorder disorder (PTSD). (See Like other mental health disorders, TBI and PTSD are chronic diseases that may cause cognitive and psychological impairment.

Goals, Objectives, and Deliverables

Goals

JMHCP offers grants to help eligible entities plan, implement, or expand comprehensive collaboration programs to improve public safety and public health for <u>preliminarily qualified individuals</u> with MHDs (including people with TBI and PTSD) or MHSUDs who come in contact with the CJ system. The definition of "preliminarily qualified offender" is outlined in the 21st Century Cures Act and codified at 34 U.S.C. 10651(9)(A). Objectives

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables and Timeline web-based form.

Enhance, expand, and operate mental health drop-off crisis stabilization treatment centers that provide 24/7 support for law enforcement, criminal justice agencies, and people who come in contact with the CJ system. These centers can provide, but are not limited to, the following services: screening and assessment, crisis care, residential treatment, assisted outpatient mental health treatment, primary healthcare services, telehealth, competency restoration, community transition, and other supports such as connections to housing.

Increase the community's workforce capacity for certified mental health peer support specialists and increase the availability of wraparound services to support people with MHDs or MHSUDs.

Build or expand capacity to identify, treat, and support the recovery of individuals at the intersection of justice and mental health at the state, tribal, and local levels.

Build or expand existing justice and mental health collaboration programs across people and places at any point in the criminal justice system—such as jails, courts, and prosecutors—as well as community supervision and/or capacity building for criminal justice professionals to target individuals with MHDs (including people with TBI and PTSD) or MHSUDs at risk of recidivism. For law enforcement-focused projects, see the separate solicitation entitled "Connect and Protect: Law Enforcement Behavioral Health Response Program."

BJA strongly encourages applicants to review <u>Behavioral Health Diversion Interventions:</u> <u>Moving from Individual</u> <u>Programs to a Systems-Wide Strategy (csgjusticecenter.org)</u>, which was developed based on work with previous JMHCP grantees.

Deliverables

Per the authorizing statute, JMHCP requires a two-phase process consisting of planning and then implementation activities during which grantees will develop a coordinated approach to implementing or enhancing services for individuals with MHDs or MHSUDs who come in contact with the CJ system. Applicants must submit one application that proposes detailed activities for both a planning phase and an implementation phase.

The planning phase will be up to 12 months long during which the recipient will have access to only \$100,000 in award funds for completion of the phase. The implementation phase will begin once the grantee has met the requirements of the planning phase, to include the recipient's completion and BJA's approval of the required "Planning and Implementation Guide," and it will continue for the remaining time of the grant.

Applicants must demonstrate that at least one criminal justice agency and one mental health agency will participate in the administration of the program through established roles and responsibilities described in an attached memorandum of understanding (MOU).

Other deliverables include:

Develop a detailed implementation plan that follows the format provided by BJA's training and technical assistance provider and aligns with the objectives listed above.

Create a public-facing report that includes information on the program's available resources to support community education and advocacy, Describe how demographic data were used to target a diverse population and include qualitative and quantitative information such as efficiencies and challenges that will increase access and inclusion and the number of people leaving the justice system and successfully connected to services.

Incorporate training and technical assistance information and best practice guidance, which will be delivered by BJA's training and technical assistance provider, into the program planning and implementation guide.

Submit a sustainability plan prior to the close out of the program. Include a description of the process for obtaining the necessary support to sustain and continue the proposed collaboration program following the federal support's conclusion.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of this <u>Executive Order</u>, OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

2. BJA will give priority consideration to rural communities. The Census Bureau defines "rural" as "any population, housing, or territory NOT in an urban area." (See https://www.nal.usda.gov/rural-development-and-communities/what-is-rural.) Its definition of rural is closely tied to its urban definition. There are two types of urban areas:

"Urbanized Areas" – populations of 50,000 or more

"Urban Clusters" – populations of at least 2,500 but fewer than 50,000

3. Program-specific Priority Areas

In addition to the priority areas listed above, priority consideration will be given to applications that:

Promote effective strategies for identification and treatment of females with MHDs who are involved with the CJ system.

Promote effective strategies to expand the use of mental health courts and related services.

Propose interventions that have been shown by empirical evidence to reduce recidivism.

When appropriate, use validated assessment tools to identify and prioritize individuals with a moderate or high risk of recidivism and a need for treatment services.

Demonstrate and ensure that funds are used for public health and public safety.

Demonstrate active participation of co-applicants in administering the program.

Document, in whole or in part, that funds used for treatment of incarcerated populations will provide transition and reentry services for such individuals.

To receive priority consideration under any of these areas, applicants must identify, in the proposal abstract, each area for which priority consideration is being sought, and describe, in the proposal narrative, how they will address each priority.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

The use of BJA grant funds for unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV) and all accompanying accessories to support UAS or UAV, is unallowable.

Cost Sharing or Matching Requirement


This solicitation requires an escalating percentage cash or in-kind match. For years 1 and 2, a 20 percent match is required. For year 3, a 40 percent match is required. Federal funds awarded under this solicitation may not cover more than 80 percent of the total costs of the project being funded in years 1 and 2, and 60 percent in year 3 of the total costs of the project being funded. An applicant must identify the source of the 20 percent and 40 percent non-federal portion of the total project costs and how they will use match funds. If an award recipient's proposed match exceeds the required match amount, and OJP approves the budget, the total match amount in the approved budget becomes mandatory and subject to audit. ("Match" funds may be used only for purposes that would be allowable for the federal funds.) Recipients must satisfy this match requirement with cash or in-kind match.

If OJP determines that an application does not include these elements, it will neither proceed to

peer review, nor receive further consideration.

Proposal Abstract

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

In addition, the abstract must:

In one sentence, identify if a program-specific priority area will be addressed in the application (as addressed in the Program-specific Priority Areas section).

Include the names of the lead applicant and the partner applicant (justice and mental health agencies); if applicable, the target population and the proposed number of individuals the applicant plans to serve; the jurisdiction's population demographic characteristics; a brief description of how the applicant plans to address the problem; and the amount of federal funding requested.

Indicate whether the applicant is a previous recipient of JMHCP grant funds and include the award number.

Include a list of proposed subcontractors, if applicable.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 15 numbered pages. Pages should be numbered and submitted as an attachment. If the Proposal Narrative fails to comply with these length restrictions, BJA may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Identify or introduce the issue to be addressed by the grant and why this program/these proposed activities are necessary (significance/value).

Describe and demonstrate understanding of the nature and scope of the problem to be addressed, using data and research as support.

Describe successful efforts to date to address the needs identified.

Describe the need for assistance and resources to address the problem.

Briefly introduce how the applicant proposes to address the problem.

b. Project Design and Implementation

Describe the strategy to address the needs identified in the Description of the Issue.

List the activities and describe how they relate to the stated objectives.

Describe the specific actions and how they will fulfill the program's objectives and reach the program's goal(s).

Provide a detailed description of the method(s) to be used to carry out each activity.

Provide a timetable/project plan indicating roughly when the activities or program milestones are to be accomplished and who is responsible.

Address whether any of the program-specific priority areas have been met.

Explain the applicant's inability to fund the collaboration program adequately without federal assistance.

Specify how the federal support will be used to supplement, and not supplant, state, local, American Indian tribe, or other tribal organization sources of funding that would otherwise be available, including billing for services already covered under programs such as Medicaid, Medicare, and the State Children's Insurance Program.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will

specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

Describe the capabilities and competencies of the applicant to manage the award.

Provide a detailed description of the capacity of the partners and the key personnel to deliver the required services and perform the key tasks described under Project Design and Implementation.

Include a letter of support from the joint applicants' agency executives demonstrating agency commitment to the project. Demonstration of the partners' commitment will contribute to scoring under this criterion.

Describe how the proposed management structure and staffing of the program will facilitate the delivery of the required services. The management and organizational structure described should match the staffing needs necessary to accomplish the tasks outlined in the timeline/plan. Information regarding the personnel assigned to these tasks and whether their résumés and role descriptions are included will contribute to the assignment of points relative to this criterion.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Example guidance to applicant - Describe the process for measuring project performance. How to Apply

Registration: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months.
