The National Institute of Standards and Technology (NIST) is announcing an amendment to its Date original NOFO posted Announcement of Notice of Funding Opportunity (NOFO) 2021-NIST-MEP-CAP-01, posted on Grants.gov, that solicits proposals for the NIST MEP Competitive Awards Program.
